Medical Cannabis as an Alternative Therapy for Seasonal Affective Disorder (SAD)

The Mayo Clinic estimates that three million cases of Seasonal Affective Disorder (SAD) are reported annually. However, about 3% of Americans are estimated to experience the symptoms of SAD every year without addressing it with a healthcare provider.

The treatment options for Seasonal Affective Disorder are limited, but there is growing research into the prevalence of SAD among patients who have other mental health conditions, such as major depressive disorder or bipolar disorder.

Medical cannabis may offer help as a new alternative treatment. Particularly for patients who experience symptoms of SAD exclusively, without the presence of another mental health condition.

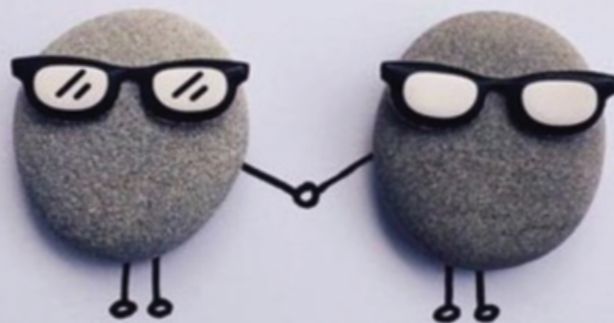

New Rules Implemented for Marijuana Licenses

After a delay of several years, Florida's Department of Health (DOH) has set in place rules for how businesses may apply for a medical-marijuana treatment center license. The license will allow a business to cultivate, process and dispense medical marijuana. However, considering the length of the delay, the fact that questions and concerns still abound is not surprising.

As background, the state's marijuana industry currently has 22 licensed operators. A state law requires the DOH to issue new licenses to correspond with the increase in the number of new patients – four licenses for every 100,000. Because the state's demographics include an aging population, more than 750,000 patients in Florida are now authorized to use medical marijuana, and that number continues to increase. For that reason, at least 22 more licenses need to be issued to keep pace with the demand.

These new rules are hoping to create a system for doing that. One states that the licenses will be handed out by "batching" them, meaning they will not all be offered at one time. This will allow those who do not receive a license the first time to apply again, although neither the length of time in between the batches, nor the number of licenses that will be available each time, has been specified.

In 2017, the Legislature passed a bill requiring health officials to set aside one license for black farmers who participated in litigation known as the "Pigford" lawsuits, which claimed federal government discrimination against blacks in allocating farm loans and assistance between 1981 and 1996. The state awarded that license in 2022, but it has been subject to litigation because the majority stakeholder of the farm died during the process and the license was not awarded. The man's family is suing, saying it should have nonetheless received the license.

In addition, the new rules include a "citrus preference," which leans toward businesses that own at least one facility that was or is being used to can, concentrate, or in some way process citrus fruit, and will use or convert that facility to process marijuana.

Most license applications require a non-refundable fee of \$146,000 – more than double that of the initial licensing fee that took place five-plus years ago – and there is concern that smaller applicants might find themselves out of the running because of the high cost.

Those who have licenses will also find it more expensive to renew them, a requirement that takes place every two years. This rule raises the cost from approximately \$60,000 per year to more than \$1.3 million for renewals due between Jan. 1, 2023, and Dec. 31, 2024. The higher fees are based on a formula that includes the amount of money it costs the state to regulate the industry.

Gov. Ron DeSantis said the reason for the increase is that medical marijuana companies weren't paying enough to operate in Florida. He added that everybody wants one and the licenses are very valuable, and this is true, as once medical-marijuana licenses are awarded, they could be resold for tens of millions of dollars.

Conventional Treatment Options for Patients with SAD

A laboratory test to determine whether thyroid dysfunction or nutritional deficits are contributing factors can be conducted for the patient. An anxiety and depression scale can also be used to learn whether the patient has an undiagnosed mental health disorder.

There are four common methods of treating patients with Seasonal Affective Disorder. Often a combination of therapies may prove effective in helping reduce the severity of symptoms for patients.

1. Light Therapy

Some patients can benefit from light therapy with an at-home device and guidance from their physician about exposure time and intensity. The recommendation is to use an at-home device that delivers 10,000 lux of light. An intensity that mimics exposure to natural sunlight to help with symptoms of SAD.

Many patients can benefit from daily light therapy and begin to notice a difference after three days. If a patient is not feeling relief after several days of exposure (usually two thirty-minute daily sessions), they can explore additional treatment options with a physician.

However, light therapy is not appropriate for all patients. Some people may experience nausea, headaches, and eye strain from light therapy. And it may not be suitable for patients on medications that cause photosensitivity or for individuals with Glaucoma or bipolar disorder.

2. Psychotherapy

Some studies suggest that while psychotherapy can be beneficial for clinical anxiety or depression, results may be limited for seasonal affective disorder. That is because the triggers for SAD are temporary, resulting from daylight deficiency.

3. Antidepressant Medications

One of the concerns about treating seasonal affective disorder with psychotropic medications is the short-term nature of symptom relief. If the patient does not have a diagnosis of clinical depression but rather transient seasonal symptoms, starting antidepressant medications for a four-month treatment period may be counterintuitive, particularly if patients experience pronounced side effects from antidepressant medications.

Wellbutrin XL is the only current FDA-approved medication for treating Seasonal Affective Disorder (SAD). Bupropion was first approved in 1985 for patients with Seasonal Affective Disorder, and it can be prescribed before the low-light season to help prevent symptoms from developing.

4. Vitamin D Supplementation

Some studies have found that patients with Seasonal Affective Disorder have low levels of Vitamin D. However, more research is needed to determine if Vitamin D therapies can help patients with SAD.

Doctor-Supervised Cannabis for Seasonal Affective Disorder

Medical cannabis is another new therapeutic option for patients. Particularly for patients who have not felt improvement in their symptoms with other treatment modalities. And there can be many advantages to using medical cannabis to treat Seasonal Affective Disorder.

First, patients who do not present with other mental health concerns may choose a medical cannabis treatment plan. One that supports their need for mood regulation during the winter months, when symptoms of SAD are most prevalent.

Physicians can customize a temporary treatment plan that may offset lethargy and low mood symptoms. Physicians can recommend specific strains of Sativa medical cannabis or balanced hybrids. Particularly strains that have terpenes that may help reduce symptoms of apathy, irritability, insomnia, and depression.

Strains of medical cannabis that may provide a mood and energy boost include:

- Jack Herer
- Harlequin GDP
- Super Lemon Haze
- Lucid Blue
- Northern Lights

Cannabis strains frequently chosen to address symptoms of mood disorders may also help patients increase focus. One of the frequent complaints patients share about some antidepressant medications is drowsiness and difficulty with concentration. For some, medical cannabis may help improve mood while maintaining alertness.



Medical Cannabis as a Complementary Treatment With Other Therapeutic Options

The medical cannabis evaluation required to become a registered patient includes a thorough review of medications, diagnoses, and patient health history. A physician has the opportunity to make doctor-supervised cannabis part of a comprehensive treatment plan to address symptoms of Seasonal Affective Disorder (SAD).

What motivates you to be a part of the cannabis industry?

People motivate me to be here, their stories; often equal parts heartbreaking as they are inspiring. I've been fortunate enough to work both in the retail side and on the patient certification side and there's no greater feeling than seeing that you have made a positive impact in their lives. You see the apprehension in first-time patients be replaced by a spark in their eyes next time you see them. You see someone barely moving, walking with assistance devices come back walking on their own. You see them in remission or taking on new hobbies. You see them living again, and it's a very rewarding feeling.

I often get asked why I do this, as my career path was never heading in this direction and my answer always varies because there are so many reasons: I do it for the arthritic grandmother who was a skilled calligrapher who was finally able to hand write invitations to her granddaughter's wedding. I do it for the child who no longer has to wear a helmet at all times to avoid injury because he's no longer getting seizures. I do it for the tormented veteran, who after years can finally enjoy a night's sleep, or a moment of peaceful serenity, free of harmful intrusive thoughts.

What field are you in within the cannabis space?

I am a Medical Marijuana Treatment Center (dispensary) manager for VidaCann. VidaCann is one of only two MMTCs in Florida that is not a multi-state operator and it is owned entirely by Floridians. In my role, I train my staff to be able to assist patients in finding products that are most likely to provide relief for their symptoms. I am responsible for the hiring, training, and education of MedTenders, inventory management, and regulatory compliance. I wear other hats as well, but I feel I am an educator first and foremost, and as an educator I owe it to the people I serve to make sure I am as knowledgeable as I can be. One of my favorite parts about my role is the ability to go to certifying physicians and speak to them and their patients about our products, what research is out there, and how to get the most out of their medicine. I feel I am an ambassador not only for VidaCann, but for medical cannabis in general.

How can people in Florida benefit from the company you represent?

If a patient is someone who values organically grown cannabis that is free of artificial fertilizers, free of herbicides and pesticides, and is grown in the Florida sun and in soil as nature intended, then my company is right for them. We also have a partnership with Stanley Brothers out of Colorado, known for Charlotte's Web CBD, which is in our Stanley Brothers ratio products, as well as we are the only company growing high THC cannabis for Stanley Brothers in the country with Miami Spice, Orange Coast, Champagne Breakfast and Tahoe Quattro strains being grown in our Jacksonville Automatic Cultivation Environment Conservatory. Additionally, we grow for Tikun Olam in Florida. Tikun Olam is an Israeli company that has been doing clinical trials and medical research with cannabis for more than 30 years, where such research is legal. This allows us to cite actual research from peer-reviewed studies and trials when recommending Tikun Olam products to our patients.

How did you get started within the cannabis industry?

I was a skeptic about medical marijuana at first. I came from a military background and southern conservative religious upbringing. I had been going through some things related to past military service while living up north and nothing was working for me as far as getting me to sleep or getting my anxiety under control. I was suffering in silence, as the Marines are fond of saying when things are less than comfortable, and you have a job to do. I had been years-deep in the VAs (US Department of Veteran Affairs) cycle of taking one pill per condition, one for the side effects, and one or two more for the side effects of the side effects medication; multiplied by several comorbid conditions and other ailments and you have a zombie just going through the motions of life instead of living it. There are millions of veterans currently stuck in that cycle, by the way. Overmedicated and barely alive. At one point, I started seeing a good friend of mine showing up on TV. His name is Mike Whiter, and we had gone on our first combat deployment together in the Marine Corps, and I'm lucky to still have him as a friend and mentor. He had been putting his freedom on the line by staging peaceful protests by publicly consuming cannabis in Philadelphia and getting arrested for it. He started alone, then more people joined him, then more until eventually, the city decriminalized cannabis and made it a citable misdemeanor, which he received the first citation. I saw how much he believed in that medicine, that it was important enough for him to make a stand and sacrifice his freedom for it. I reached out and had some conversations with him and that convinced me to give it a try. Effects were immediate and profound. Fast forward about 2 years and I was finally sleeping and had almost eliminated PHARMA's iron grip. I felt I had my health back. I was corporate middle management at the time and unfortunately there was a situation that required me to terminate employment for someone who had failed a post-accident

drug test for cannabis. This person was spectacular at their job and I felt the crushing weight of hypocrisy and a conflict of values, how unfair this situation was and how helpless I was to do anything about it. So I decided to leave the Kush life for the Kush life. I moved back to Florida intent on getting in on a nascent industry and found myself getting hired as a manager to open a new dispensary in Jacksonville.

Are you personally a MJ card holder?

I am. I have been a patient for more than 4 years now. My experiences as a patient have been very influential in how I approach my role as a dispensary manager. I was there at the beginning, when there were limited options when it came both to where to purchase medicine, and what type of products were available. There was no whole flower, there were lines, there were inferior products, not enough to meet demand, all those things. Now, you absolutely can be a successful manager in this space without being a card holder but being a card holder gives me the experience of knowing what patients go through because I'm a patient first and a manager second. I can share personal experiences with products and can relate to patients more effectively because of it. When something new comes out, I'm just as excited to try it as they are. More research is needed, and I always do my homework.

Do you see Florida moving forward with recreational marijuana/cannabis and how will that affect your business?

I do. I think it's inevitable. I don't sit in on long-term strategy planning, so this is all speculative opinion. I believe we are going to continue to serve medical patients and make them a priority because that is where we have been most successful. We will certainly serve adult-use patients, as there will likely be an explosion in demand that I don't believe any of the MMTCs serving patients in this state will be able to meet right away. In short, I anticipate that selling out of products will happen, which as a retailer is a good problem to have. But from a customer retention standpoint, I'm sure there's a plan in place to re-stock as quickly as possible. There will certainly be an industry-wide adjustment period and growing pains related to being able to meet the demand. I don't think we'll be any different. It would be wise as an industry to keep in mind that the legacy market will be ready to meet that increased demand, so I have always viewed legacy operators as legitimate competition. From a regulatory standpoint, it will be interesting to see to what extent the rules related to packaging and marketing advertising will be adjusted. Personally, I'd like to see workforce protections for cannabis use as in other states. I'd love to see that become a priority, because there are many people suffering in silence because medicating with something that is both legal and safe is still seen by the same state that licenses and sanctions it as a threat to their livelihoods. Florida is a tourist state, so I foresee CannaTourism becoming its own emerging industry with everything from consumption lounges, consumer-friendly accommodations, guided tours, culinary endeavors, and guided experiences/tours being among the many possibilities, so it will be very exciting to see.
