Will Medical Cannabis Patients Switch to Recreational Use in Florida?

BY JACKIE ROTHMAN

When a state discusses legalizing adult-use cannabis, there are many concerns shared by healthcare providers. In Florida, we are seeing a strong push toward legalizing recreational use. Whether it will happen or not is anyone's guess.

One of the worries that healthcare providers have is the perspective shift. What will happen if patients with medical conditions who benefit from doctor-supervised cannabis opt out of the Florida medical cannabis program?

Based on the behavior of patients in other states that moved to legalize recreational cannabis, some patients may leave the program. But many will stay. And the number of patients that remain registered with OMMU might fluctuate, depending on how the recreational laws are established.

The Smart & Safe Florida initiative has gathered enough voter signatures to allow recreational use to be reviewed by the Supreme Court. Now healthcare providers are asking what will happen if adult-use (recreational) cannabis becomes legal in Florida.

The Benefits of Doctor-Supervised Cannabis

Patients need the advice and guidance of physicians to make a safe and

Sunburn Cannabis Going Deep, Not Wide, in Florida Market

Brady Cobb knows cannabis and he knows what his customers want. After building and scaling Bluma Wellness and One Plant dispensaries in 2019 and selling it to Cresco Cannabis in 2021, he realized that something was still missing in the market.

"It's all about honoring the plant," said the owner of Green Sentry, which recently launched the Sunburn Cannabis brand across Florida.

To Cobb, honoring the plant means creating a premium cannabis brand authentically grounded in Florida's distinct cannabis culture and selling only the highest quality cannabis flower, concentrates, edibles and related products.

"We're not just pushing product through; we're not a minute clinic," said Cobb. "We brought the right genetics and a good mix of genetics into the market, and we let each plant tell us when to finish cure," he said. "It's much more of a craft approach to cannabis than anyone else is taking. One size does not fit all."

After One Plant was sold to Cresco, Cobb stayed for about three months before deciding to move on.

"There was nothing wrong with doing things their way; it was just not for me," he said. "It was a really humbling moment when my team wanted to leave with me. We

New York State Department of Health Highlights Publication of Study on the Role of Medical Cannabis for Chronic Pain in Reducing Prescription Opioid Dosages

The New York State Department of Health announced that its latest multi-agency study detailing the association of receiving medical cannabis for 30 days or longer with a reduction in prescription opioid dosages has been published in the Journal of the American Medical Association (JAMA) Network Open.

The results of the peer-reviewed study, Changes in Prescribed Opioid Dosages Among Patients Receiving Medical Cannabis for Chronic Pain, New York State, 2017-2019, in combination with existing evidence, show that managing chronic pain with medical cannabis may reduce the opioid burden. This may, in turn, reduce the risk of illicit use and overdose for patients on long-term opioid therapy.

"Medical cannabis is increasingly being used as a treatment in pain management and this peer-reviewed study is further evidence that medical cannabis has the potential to reduce the amount of opioid-based medications needed to treat chronic pain." Acting Health Commissioner Dr. James McDonald said. "I applaud the work done by members of the Department, as well as the Office of Cannabis Management and CUNY. These findings have the potential to further inform health providers and policymakers here in New York as well as in other jurisdictions where medical cannabis is not yet legalized or used to its fullest potential."

In this study, published in the JAMA Network Open's January 30 issue, Department researchers and colleagues from the CUNY Graduate School of Public Health and Health Policy and the New York State Office of Cannabis Management analyzed data for more than eight thousand adult New Yorkers from 2017-2019 and concluded that receiving 30 days or more of medical cannabis for chronic pain is associated with a reduction in dosages of prescription opioids among patients who were on long-term opioid treatment.

The study found that those who were on higher baseline dosages of prescription opioids (when they started receiving medical cannabis) saw a larger reduction in prescription dosages after eight months, upwards of 51 percent for individuals on the highest baseline dosages of prescription opioids.

What are the benefits of using a topical?

According to Leafwell, topicals can have many benefits for users including overall relief in pain and inflammation, a reduction in acne, anti-aging qualities for skin, migraine pain relief, alleviating cancer-related neuropathic pain, a reduction in eczema and psoriasis, moisturizing the skin, alleviating symptoms related to neurological disorders, increased sexual pleasure, aiding in wound healing, and more.

How do you use a topical?

For use, apply the topical until the entire desired area is covered; usually, every 3 hours as needed is a great start. If you find that you want to apply more before or after that 3-hour window, feel free to do so. How long does a topical take to work?

What are the effects of topicals? Do topicals get you high? Will they show up on a drug test?

Lotions or salves do not get you high. A topical product can have a lot of THC in it, and you still will not get high from it due to how your body absorbs it. Why have THC in the product if it doesn't get you high? THC has been known to work wonders for reducing pain, even in topical form. Depending on the test's sensitivity and the application's frequency and location, THC from topically applied cannabis may show up on a drug test.

How strong are topicals?

There are tons of cannabinoids, the active ingredients of cannabis, in Insa's tinctures. For example, each jar or lotion has at least 400mg. This high amount of cannabinoids can offer a great deal of relief. Remember, as with all cannabis products, check the label before use, as the amount of THC depends on the cannabinoid ratio. The ratio of CBD to THC that you should choose depends primarily on your desired effects.

Which topical is right for me? What's the difference?

The Insa lotion comes in a THC only option that contains 400mg of cannabinoids. BDSA Reports Global Legal Cannabis Sales to Reach \$59.6 Billion in 2027

BDSA, the leading provider of market intelligence for the cannabis industry, released its updated five-year global legal cannabis market forecast. Global legal cannabis spending grew 4.8% to \$32 billion in 2022 and forecasts a compound annual growth rate (CAGR) of 13.2% from 2022 to 2027, resulting in a market size of \$59.6 billion by 2027. Despite economic uncertainty and rising inflation, BDSA expects legal U.S. cannabis sales to grow 14% by the end of 2023.

“Legal cannabis spending slowed significantly in 2022 due to rapid price declines across all markets,” said Roy Bingham, Co-Founder and CEO of BDSA. “Despite this, our updated forecast predicts strong growth in the U.S. driven by developing markets, particularly the adult-use markets of Missouri, New Jersey and New York. Additionally, four of the top five U.S. markets—Florida, Illinois, Massachusetts and Michigan—will increase by a combined 9.5% in 2023, adding nearly \$770 million in new spending.”

While legal cannabis sales saw rapid growth during the height of the pandemic, 2022 marked the first overall spending contractions in many mature markets throughout the U.S., with the mature adult-use markets of California, Colorado, Nevada and Oregon suffering a combined spending decline of 16.5%. While BDSA expects to see a return to growth for most mature markets in 2024, mature markets in the U.S. are expected to grow slower during the forecast period. However, several newer markets accomplished a strong

expansion in 2022, and growth in new and emerging markets is expected to ramp up in the coming years. New Jersey and Montana, which launched adult-use sales in 2022, saw approximately 140% growth last year, while Missouri grew by 84% in its second full year of medical-only sales.

By 2027, adult-use sales are forecasted to contribute 78% of the total global legal cannabis spend, up from 64% in 2022. U.S. legal cannabis spending is expected to grow at a CAGR of 11.3%, from \$26.1 billion in 2022 to \$44.5 billion in 2027, driven primarily by the New York, Florida, New Jersey and California markets. BDSA forecasts the launch of several new adult-use markets by 2027, including Maryland and Oklahoma in 2024 and Florida and Ohio in 2025. New adult-use markets in Hawaii and Minnesota are also possible. Although BDSA does not expect any comprehensive U.S. federal regulations on cannabis in this timeframe, there is a possibility of partial reform, such as cannabis banking, within the next few years.

Globally, cannabis markets beyond the U.S. and Canada are forecast to grow at a CAGR of 40% to \$9.5 billion in 2027, up from \$1.8 billion in 2022. BDSA forecasts the Canadian market will see 12% overall growth this year, becoming a \$5.7 billion market by 2027 at a CAGR of 6.3%. New adult-use markets and Germany and Mexico are the primary drivers of global growth, and current limited medical cannabis programs are expected to expand, primarily within the European Union and Latin America.

didn’t have anything set up, but we wanted a chance to do things our way—the right way, by honoring the plant.”

Sunburn Cannabis has now taken root, and has been expanding across Florida after Green Sentry bought all 13 of the Florida locations of MedMen, which closed in August 2022.

“One of the things that drew us to MedMen was how well their retail stores were sited and how beautifully built out they were,” Cobb said. Since Nov. 16, 2022, eight of the MedMen locations have opened as Sunburn Cannabis, and two more, in Jacksonville and Key West, will open in March. The next two stores in Deerfield Beach and Miami Beach will open later this year.

“It’s been quite the run,” said Cobb of Sunburn’s amazing growth.

In addition to honoring the plant, Sunburn is also honoring the history of cannabis in Florida—a story that includes Cobb’s late father, Miami smuggler Clyde Walton ‘Bill’ Cobb.

“He moved a lot of weight through Florida from Columbia,” said Cobb. “We’re not some out-of-state MSO (multistate operator) like Jungle Boys or 710 Labs. Our story showcases Florida cannabis culture.”

Though the Florida market has grown quickly over the past few years, Cobb said that he’s not worried about being the new kid on the block. “If I was entering the marketplace selling biomass and dis-

tillate, I’d be very concerned; so much of that market share has been pried up that it’s a very competitive area with a lot of people fighting for the same consumer,” he explained.

“We are going after the top end of the market and truly building a brand that is different than what our competitors are doing in terms of retail experience,” he added. “While there are a lot of retail dispensaries in Florida—we recently crossed the 500 mark—the state has 21 million people and the population is still growing. If you have stores in tertiary locations, there might be reason for concern, but that’s why we focused on MedMen’s prime locations. You don’t need 80 stores in B locations; you want 20 to 25 stores in A locations—that’s why we’re going deep and not wide into Florida.”

While the state has not yet passed legislation allowing the use of recreational marijuana, Cobb believes that it’s just a matter of time. “Florida becomes the number one market in the country when that happens—we have 118 million visitors a year over the age of 21, with the bulk coming from states where cannabis is illegal,” he said.

Though Green Sentry has filed an application in Alabama, they plan to remain a Florida-focused management team for the foreseeable future. “We’re looking at potential expansion outside, but we’ll remain uniquely focused on the Southeast,” said Cobb.

informed choice about medical cannabis. And physicians who conduct medical cannabis health evaluations spend time discussing more than the qualifying health condition.

Doctors closely examine the patient’s medical history, including the patient’s current diagnosis. A review of current prescription medications and supplements is also done to ensure that cannabis is not contraindicated.

The physician also has an opportunity to ask about symptoms and advise the patient on routes and certain types of strains which may help the patient meet their wellness goal. And the patient knows that if they have a question or if their medical condition changes, they can talk to their recommending physician.

Medical conditions can change over time. Establishing a relationship with a provider with extensive knowledge about cannabis provides a reliable resource for the patient. As their health needs evolve, the physician can help ensure that cannabis remains a safe therapeutic choice for them.

Challenges of Recreational Cannabis Use and Population Health

The first concern is always public safety. Because when you remove the guidance of a certified physician, there are many risks to consider. How educated are Florida residents regarding potential health risks?

When you remove the physician from the equation of legalized cannabis, it can increase risks for patients—particularly those with complex medical and health conditions. When patients are not enrolled in the medical cannabis program in Florida, they will not be required to schedule initial or follow-up appointments with doctors.

One study published in the *Journal of Nursing Scholarship* on October 17, 2022, by

researchers at Florida Atlantic University stated that cannabis was a “legitimate public health concern.” However, much of the data referred to synthetic cannabis (Delta-THC) products. Not medical cannabis produced by reputable dispensaries.

The challenge (if recreational cannabis is legalized in Florida) will be educating all residents over twenty-one (21) on responsible and safe use. And that will require statewide initiatives and ongoing campaigns for public safety.

Why Many Patients May Stay in the Medical Cannabis Program

A large number of patients rely on the advice that they get from their physicians about medical cannabis. When you are coping with a complex health condition, the last thing you want to do is worry whether cannabis could be harming your health. It is easier to speak directly with a provider to get the answers you need.

In other states that have initiated recreational cannabis, benefits were established to encourage people to join (and remain) in the patient registry. In some states, patients with a medical card are permitted to purchase larger quantities of cannabis per month. Sometimes higher potency cannabis is also limited to patients with a medical card.

One strategy that many states have used is a differential excise tax system. Recreational cannabis consumers may pay a substantially higher retail tax on products, devices, and supplies than patients with medical cards.

Some states, like New Jersey, eliminated all sales tax on cannabis for registered patients. The state sales tax on medical cannabis purchases is currently \$0. That cost-saving benefit helped keep patients on the New Jersey medical cannabis registry.

And it could work in Florida as well.
